Volunteers work doing food prep, dishwashing, cleaning the kitchen and cafe, bussing tables, wiping tables and chairs, watering plants, cleaning windows and bathrooms, taking and delivering orders, and setting up or tearing down the cafe before and after service. The volunteers donated at total of 10,077 hours.
